Tamil Nadu Educational Rules

I hereby declare that I have inspected the **KRISHNASAMY VIDYANIKETHAN, SENIOR SECONDARY SCHOOL,(CBSE) MARUTHADU ROAD, S.KUMARAPURAM, CUDDALORE TALUK & DISTRICT** building and premises on the day of **26.03.2024** and certify

- : that the accommodation provided for each of the several classes is sufficient for the minimum number of pupil taught therein and is properly ventilated and lighted;
- : that the building is maintained in substantial repair;
- : that is neat and clean;
- : that the latrine arrangements are adequate and satisfactory;
- : that the supply of drinking water is protected and wholesome; and
- : that in all other necessary aspects the sanitation is Satisfactory.

Subject to condition

1. The Toilet and Urinals should be disinfected twice a day.
2. "One Time use Plastic" should not be used in the College premises
3. Tobacco prohibition board should be displayed in the College premises 60 x30 cm containing warning "NO SMOKING AREA, SMOKING HERE IS AN OFFENCE"
4. No sale tobacco within the radius of 100 meters of the educational institution (Head Master/Principal should ensure)
5. No sale of tobacco inside the premises of the institution.
6. No smoking or chewing of tobacco inside the premises of institution.
7. Incinerators to be installed (applicable only for schools with adolescent girls)
8. All the government (state/Central) health schemes to be implemented without any deviation

That if any of the above conditions are not satisfied the certificate given will be withdrawn.
