4. No sale Tobacco within the radius of 100 meters of the education institution.
5. No sale Tobacco inside the premises of the institution. (Head Master / Principal should ensure)
6. No smoking or chewing of tobacco inside the premises of the instituion.
7. Incinerators to be installed (applicable only for schools with adolescent girls)
8. All the government (State / Central) health schemes to be implemented without any deviation.

That if any of the above conditions are not satisfied the certificate given will be withdrawn.

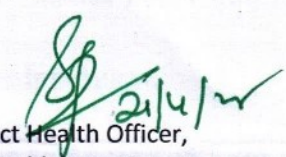

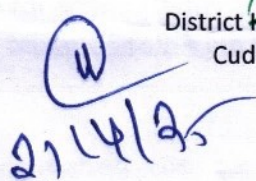
